THEME PRESENTATION:

In a continuous process of change and adaptation to producers' and consumers' requirements, to the environmental problems, under the pressures of climate changes, in order to reach sustainable and inclusive development, the Common Agricultural Policy (CAP) post-2020 has the key objective to continue improving the sustainability of agriculture and rural areas in the European Union (EU) member states, complemented by the cross-cutting objective of sectoral modernization by stimulating the exchange of knowledge, innovation and digitization in agriculture and in rural areas and encouraging their uptake.

The priorities for the next budgetary period of CAP were outlined during the debates on a new CAP reform, which gained consistency in November 2017 with the publication of the European Commission Communication on the future of food and farming in the EU, preceded by a public consultation on the moderrnization and simplification of the legal framework, which confirmed that the existing political instruments have managed to address only partially the current challenges, mainly those related to climate and environment, areas where most farmers and other stakeholders consider that the CAP should do more.

The new political vision designs a smarter, more modern and more sustainable CAP, which should provide support for fair incomes for farmers, finance investments for improving the position of farms on the food chain and for a competitive food supply chain, to ensure risk management, environmental protection and fight against climate changes, while contributing to strengthening the socio-economic structure of rural areas and attracting young entrepreneurs in the farming activities.

At the same time, economic growth and job creation in the countryside remain CAP priorities, as the rural areas are facing structural problems such as lack of attractive employment opportunities, lack of investments in basic services and young people's low interest in remaining in the rural area. The rural workforce should have better access to vocational training, to skill development programmes, to quality education, information and connectivity. The new value chains in the rural area, such as clean energy, emerging bioeconomy and circular economy can create jobs and new opportunities in the countryside.

For Romania, agriculture is a strategic sector, which needs greater political determination to foster sector growth in accordance with the potential of natural resources, as well as an awareness of the limits that sustainable development demand on economic activities in relation to environment and natural resources.

The expected results of the works of this scientific session are circumscribed to a realistic assessment of what the financial exercises meant for the agricultural sector and rural economy after Romania's accession to the EU, as well as what are the socio-economic and ecological effects of CAP implementation, which are the advantages and disadvantages of the impact and especially how certain policies and effects that are less satisfactory can be corrected.

Investigating how Romania has used the opportunities provided by the EU membersip in the interest of its sustainable rural development and food security, generating proposals on adapting CAP interventions to the current domestic needs, in order to increase the effects of political measures on Romania's agriculture and rural area, in European context, and identifying possible solutions regarding the future sustainability challenges at social, economic and ecological levels, require a complex thematic approach, providing the necessary framework for new opportunities for scientific studies and research.

OBJECTIVES:

The aim of this scientific event is to bring together researchers, academics, experts and decision-makers in the field of agri-food economy, rural development and from other related areas, to debate theoretical, methodological and practical issues concerning the sustainable development requirements, limits and opportunities, at national and European level, in the context provided by CAP modernization and simplification for the financial programming period 2021-2027.

The participants are invited to present the results of their recent research work in the investigated fields. The session will also represent an opportunity to develop new partnerships and identify new fields of cooperation in scientific research.
