Instructions on the forms of the abstract to be submitted

for obtaining the academic degree of doctor

Volume: the volume of the abstract, including the English summary, should not exceed two printed plates (32 pages); The mentioned quantity means all pages.

Language: the abstract must be written in Georgian and an English summary must be attached (volume - 500-800 words).

Structure: The title page of the abstract should be formatted according to Appendix 1. The abstract should reflect: actuality of the topic, scientific novelty, the purpose of the work, the object and methods of the research, the main results of the research and the field of application of the results, information about the scope and structure of the thesis, the main results of the thesis according to the chapters and general conclusions; The abstract should contain information about the aprobation of the work (reports at conferences, forums, symposiums, seminars), as well as a list of published works, patents and copyright certificates, the content of which corresponds to the topic of the thesis and is included in the thesis.

Paper size: The abstract should be written on A4 format (2972210 mm) paper, on 80 g/m2 density paper. Orientation – vertical.

Margins: left side – 38 mm, other sides – 25 mm.

Font: the main part of the text should be in any standard font (preferably the following fonts: Sylfaen, AcadNusx, AcadMtav, Litnusx, Literaturuli_BJG_2000), size 12. The text should be printed on a laser printer or other printing means that provides similar quality.

Titles of Chapters and Subchapters: The font size of the titles of chapters and subchapters may be larger than the font size of the main text. The subsection should continue from the same page; It is not allowed to leave a free space or a page.

Page numbering: All pages, except the title page, must be numbered consecutively. Pages are numbered on the bottom edge in the center with Arabic numerals. The font size of the number should be 10.

Line Spacing: Spacing for body text should be 1.5.

The title page should be formatted as follows - it should contain the text: Technical University of Georgia, with copyright, name and surname of the doctoral student, title of the dissertation, doctoral program, font, Ph.D. abstract of the dissertation submitted for obtaining an academic degree, Tbilisi, year.

The second page should include the name of the institution and structural/organizational unit where the work was completed, supervisor, reviewers, at which University Dissertation Council session the thesis defense will take place, time (year, month, number, hour) and place (address, building and auditorium number)). Time and place of thesis defense will be recorded manually. Finally, it is signed by the secretary of the Dissertation Board.
